C. Planning of Opening of Sagan Inilao and Website Kickoff, Ha'ånen Hila' Nåna, February 21, 2025: Kumisión will be joining forces with the Department Of CHamoru Affairs.

Website: Si LMTS ha fáfaisen i membro håfa malago'-ñiha parau ta cho'gue guini na ha'åni yanggen ta launch i nuebu na website. Mamaisen si HAC håfa rekumendasión-ña si LMTS. Ilek-ña na maolek yangen ta kombida todu i Mahót siha, i gubietnamento siha lokkue' ni' ti ma gof tungo' i che'cho'-ta siha guini gi i Kumisión. RSP is recommending inviting all schools to involve childen in this effort; perhaps to have them read CHamoru original pieces they wrote or/and read stories written in the CHamoru language, or any other languages. Mayors and Gov't agencies can observe the children's presentations.

LMTS recommends that children read our books and products.

RSP recommends having the event for 3 days and LMTS suggests starting on 2/21/25, and to invite all schools from håya, lågu, luchan yan kåttan to present.

#### IX. RIPÓT I ATMENESTRASION

A. Report on December 27, 2024 Feeding Initiative (MD-C) MSDC reported the good turn out. HAC and EC came with her family. RFM brought goodie bags for children but there were none, which is a good thing.

B. Presentation and approval of Website Concept (FS)
FS presented to the Board Member and the staff. FS did research on numerous websites and found that the Harvard website was the best to meet our goal, use their knowledge and mirror their concept. The Website Goals - Accessibilities, Enhanced Functions & Features, Showcase Products 7 Services, Community Outreach. FS then shared to compare the old and the new website.

LMTS: Will have a carousel on the landing page that showcases pictures of kids reading so it's not a single dimensional experience.

#### C. Fino' i Ha'ani - Fibreru (LC)

LC reported that she sent the list yesterday. If changes need to be made please send it to her for the update. Once that is done they will move forward to record and send files to appropriate individuals for publishing. RSP said she will submit her revisions early next week.

D. Self-Determination Exhibit (PT)

PT shared the exhibit outline for the 8 panels being created to include the panel number, time frame, and action.

RSP mentioned that she did the CHamoru translation back in the 1980's on Hurao's speech and have made revisions in 2017 of the copy. RSP will be sharing the revision with PT to make the changes on the exhibit for Self Determination. She also asked if the book on Self-Determination edited by Anthony Leon Guerrero will be part of the Exhibit documents.

PT had shown and explained samples of the panels explaining dates and LMTS mentioned that every photo and article has a QR code for our middle and high school students to easily access the documents when doing research. The QR code will lead to the actual article and photo.

RSP is asking where these exhibits will be displayed and how many panels are there. PT reported 10 total panels, 8 of which will be on self determination and 2 on genealogy.

It will be a travelling exhibit and schools may utilize them if they need.

MWPB has materials and articles from the 9th Circuit Court. He will share resolutions to the Kumision. MWPB will work with his team and PT to get more materials to assist in producing the remainder of the Exhibit.

E. Professional Development Opportunities for Staff (MD-C) MD-C reported that Staff Development Day for the Kumisión staff has been successfully kicked off and held their first Staff Development Day this past Tuesday, Jan. 7, 2025. The team was able to contribute to ideas for our workshops. The staff had presented on sacred sites and started their first work session for CHamoru History presented by LMTS. If any board member is interested in presenting at these work sessions or staff development days they should contact MDC. Staff continue to do Fino' i Ha'åni daily as well as reflections. The goal is to ensure the staff are knowledgeable on the products, website, language, culture, and our CHamoru History. Staff are also being trained to work with other staff to

ensure that the operations do not stop even if a staff member should happen to be out.

F. Scheduling of Board Members for Interviews (LC/LL) LC reported to have the board schedule the Orthography and Linakngos Linakse' project with her or LL. She had gone through the Orthography scheduling with all board members recording on who is designated on what rule section. She had encouraged all members to schedule the recording asap.

G. Report on FY2026 Budget Submission to BBMR (MD-C) MD-C says The FY2026 Budget Request has been officially submitted to BBMR on 12/20/2024. The FY2026 Executive Budget Request Program Listing has been updated and has been submitted to BBMR as of 1/09/2025.
