## IX. RIPÓT I ATMENESTRASION

A. Fino' I Ha'åni (Hunño) - (PT)

PT reported she received a list of words for the months of June, July, and August. June and July were submitted to the Fino' Committee for review. RSP reported that the Fino' Committee will meet on Thursday, May 15 from 9-12 noon to review the revisions made on the June Fino' i Ha'åni and the place names listing from Caroline Goughis from the National Park Service.

B. Linakngos Linakse' Interview List - (LL)

LL reported she updated the Linakngos Linakse' list. Thus far, 11 interviews are completed. LL reported that she received some suggestions from TCF. If anyone else has suggestions we can add them to the list and start scheduling for recordings when they are available. LMTS reported Board Members are the main priority, and that they need to submit their questions. Board members must generate questions toward the interviewer that highlights the work they've done.

C. Resignation of Francisco Santos effective date 5/16/2025 (MDC) FS effective date of resignation will be 5/16/15. He has already transferred his responsibilities and communicated with all of our partners to inform them. and we have already started the transition prior to his departure.

D. Proposed position change for Elerida Cruz to Management Analyst III or IV (MDC);

MDC reported we have been trying to change EC's status for quite a long time, MDC reports per the Governors office she is allowed to put someone in charge anytime she is on leave. EC is aware of the tasks done and what the staff has to do.

E. Recruitment of Multimedia Tech I in lieu of FS's position (MDC):

MDC reported we have asked for a Multimedia Tech I position to be a part of our staffing pattern for LL's assistant. The new staff will assist with edits and everything else that have been recorded so they

would put them up on our website and social media. The formal recruiting will start once FS is officially clear. Then, we would need to look at the listing first and go with that listing.

F. Nina'Fitme Cohort IV completion ceremony diha 5 gi Måyu, 2025, 4pm, GCC Multipurpose Room (MDC):

MDC reported this was our fourth and final cohort with a total of 9 graduates. 1 of the 9 had unfortunately passed, Norma Jean Ogo. Her family was there to receive her certification on her behalf. The class performed a tribute to her passing. At the end they performed a skit on not using drugs.

G. Decolonization Conference on May 6-7, 2025, 8am-4pm, Hyatt Regency Guam (LMTS/MDC):

MDC reported on day one we got to hear from Dr. Underwood, Attorney Levin Camacho, and Leiland Bettis fostering advocacy through community mobilizations. In the afternoon we heard from LMTS, HAC, and Dr. Vivian on Social Issues and Connections to Decolonization. During the afternoon we had a performance from Intetnon Gef'pågo.

PT reported on day two. She reported the keynote speaker was Dr. Kenneth Gofigan Kuper. During his speech he emphasized that Guam must reclaim its narrative from being seen as only a U.S. military site. Through power and foreign diplomacies Guam can build relationships and advocate for itself and its interest. He also spoke on the serious investment in trained negotiators and diplomats as an essential course of action. Leiland Bettis, Dr. Lisa Natividad, and Larry Regital's session highlighted the challenges Guam faces as a U.S. unincorporated territory when its political status enables itself to speak independently. They reflected on history experiences and strategies such as guerilla diplomacy and solidarity with other Pacific nations. They also spoke on the importance of consistency advocacy and communication and involvement.
