IX. RIPÓT I ATMENESTRASION

A. Liberation Participation (MDC): MDC reported that during the Cabinet meeting all agencies are required to participate in the parade. However, for the Kumisión we came to a consensus to break it in half. MDC says half of the staff will be with her in a vehicle and wave with her, while the other half will be at the festival. Or, another option is to put the mañaina in a trolley or van. For the Liberation Festival, we are asking if the mañaina can support from 3-

5pm. LMTS reported she spoke with Mayor Alec's assistant. They agreed we can do Saturday - Sunday 10-8pm, and Monday 3-5pm. We will have our booth in the Songsong CHamoru and it will be shared with Decolonization with MWPB. Board members will have slots and employees will have slots. We will be placed in elevated huts, however MDC did request for us to move so we can be closer to the bathroom. There are also outlets there for us. We will be putting up our exhibit for self determination and think of ways of sharing our work/products. JST will communicate with YMLG for MDC to come up with ideas for the festival for collaboration as JST is off-island until the end of July.

B. Status of website/social media (PT): PT reported we are tracking with our website, she has already reached out to Darryl, the Ideal Advertising POC to go ahead and move forward with creating the manual so she can start editing and creating pages. PT says they are currently working on it, and they will get the official training so she can start uploading content herself. PT further reported we are just about done linking all pages from the landing page, and started to implement metadata from the pages that are linked on the landing pages and we'll just continue to keep tracking for that. As for Social media as of today we have 61.4k views within 30 days on Instagram, We had a slight increase from the last report. We will continue to push products. PT reported our newest project is to reach out to CHamoru authors and collaborate and have them narrate their stories. I Biahan Kiko, A press release was done yesterday. I Biahan Kiko' wil be recorded first followed by I Malingu na Påtgon. If any of the Board members would like to narrate in CHamoru reach out to PT.

C. Media update (LL): LL reported, with the help of the production team, that they were able to update the production schedule. PC was the lastest interview; and LMTS & RFM have recorded their books. D.Genealogy Training Update (LC): LC reported there will be a lot of families that will be inputted into the family tree. She reported there's a total of 6 family

trees from Siñora Lisa Bitanga that have been vetted already. She continues to get families to submit their info into the database. The team is working with AQ's family tree and will provide him with a copy. RFM and RSP have copies of their family trees that they would like to be inputted into the Family Tree. E.
