WHEREAS, Major General Reginald Neal is the Deputy Commanding General for the U.S. Army Pacific (USARPAC), Mobilization and Reserve Affairs, stationed in Fort Shafter, Hawaii;

WHEREAS, originally from Ludowici, Georgia, Major General Neal became well-versed in leadership, graduating with an AS in Business Administration and Military Science from Georgia Military College, a BS in Education from Georgia Southern University, an MS in Educational Leadership at The Citadel, an EdS in Education Administration at Argosy University, Orange County Campus, an MSS in Strategic Studies from the United States Army War College, and an Ed.D in Education Administration from Argosy University;

WHEREAS, in his capacity in the military, Major General Neal expanded his knowledge and training to include the Field Artillery Officer Basic and Advanced Courses, the United States Army Command and General Staff College, Enhanced Defense Financial Management Training Course, Dual Status Commanders Course, Joint Task Force Commanders Course (NORTHCOM), Army Security Cooperation Course, Combined Joint Forces Land Component Commander Course among many others;

WHEREAS, Major General Neal's most notable assignments include the G3, J1, and Director of the Joint Staff for the Georgia National Guard and the Executive Assistant to the Chief of the National Guard Bureau (CNGB) at the Pentagon;

WHEREAS, Major General Neal demonstrated his strong competency as a leader working under strategic-level military planning committees, including the Combat Vehicle Task Force, the Field Artillery Advisory Council as the Battalion Commander Sub-Committee chairman, the past-President of the National Guard Association of Georgia. Currently, he serves on the National Guard Bureau's (NBG) Joint Diversity Executive Council (JDEC) and the Joint Officer Management Advisory Council (JOMFAC);

WHEREAS, as the United States Army Pacific (USARPAC) Deputy Command General, Mobilization and Reserve Affairs, Major General Neal was a strong advocate for our island, prioritizing the need for a balance regarding the growing presence of military on Guam and the concerns and issues from the community, most especially in areas of culture and the environment;

WHEREAS, as an ambassador for the island through the Guam Army National Guard (GUNG), Major General Neal championed an increase in GUNG's budget, manpower, and control of the defense of our island. Through his leadership and extensive knowledge, he advocated for regional partnerships that pushed for assistance to be provided to Guam, playing an essential role in the U.S. State Department's approval of the Guam-Palau State Partnership;

WHEREAS, Major General Neal was a key supporter of uplifting the lives of those in the community promoting the expansion of Veteran Care among Guam, the CNMI, and the Republic of Palau. Most notably, during Typhoon Mawar, he worked alongside local, federal, and civilian partners to facilitate a joint response to rebuild our island community. Through the guidance of Major General Neal and other leadership, many residences damaged by the typhoon were able to temporarily repair their metal roofs under the Roofing Installation Support Emergency Utilization Program (RISE UP);

WHEREAS, Major General Neal, in his capacity, demonstrated a profound interest in the well-being of the community of Guam and the formidable defense of our island. Among his many accolades and sound understanding of leadership and military operations, Major General Neal has left an indelible mark for the island to cherish for the years to come.

NOW THEREFORE BE IT RESOLVED, on behalf of the Island of Guam, Major General Reginald G. A. Neal is hereby honored with distinction and extended our enduring gratitude and respect.


